Several elements of the Lead and Copper Rule Revisions (LCRR) will be required starting on October 16th, 2024. The Finalized Lead and Copper Rule Improvements (LCRI) is expected to be released prior to October 16, 2024 and contain details on future regulatory requirements. This session will provide water systems with the latest information related to Lead and Copper drinking water regulations and how they should be preparing for current and future compliance obligations. California specific requirements will be discussed where applicable.

Continuing Education & Contact Hours: In order to earn 3 IACET Continuing Education Units, students must attend all 3 hours of class. Those with partial attendance or not passing the final exam will earn one contact hour for each hour of class attended.
